# 1. INFORMATION AND SCOPE OF INSPECTION

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without the need to move any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right are taken facing the front of the property.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. were not inspected or reported on.

**Description** Glenerne comprises a single storey property, with

outbuilding and garden ground.

**Accommodation** Sitting Room/Kitchen, Two (2nr) Bedrooms, Bathroom, Hall.

Gross internal floor area The gross internal floor area of the property is approximately 62m2.

Neighbourhood and The property is situated in a rural location in Westray, which is one of Orkney's outer north isles.

Age The original house is assumed to date from the early

Twentieth Century.

The property was completely renovated in around 2012

(per the current owner).

**Weather** The weather was dry and cool, following a period of

changeable weather.

**Chimney stacks** There are two (2nr) stone-built chimney stacks; both are

harled and have single clay chimney cans.

Visually inspected with the use of binoculars where appropriate.

# Roofing including roof space

Pitched timber framed roof structure, clad externally with concrete tiles.

Concrete ridge tiles.

Leadwork flashings to the chimneys.

Sloping roofs were visually inspected with the aid of binoculars where appropriate.

No access to inspect the roof spaces.

# Rainwater fittings

uPVC gutters and down pipes.

Visually inspected with the aid of binoculars where appropriate.

### Main walls

Stone walls, harled externally; flagstone external window cills.

Timber fascia boards to the front and back elevations.

Visually inspected with the aid of binoculars where appropriate. Foundations and concealed parts were not exposed or inspected.

# Windows, external doors and joinery

uPVC double glazed windows and external door. Velux roof windows.

Internal and external doors were opened and closed where keys were available.

Random windows were opened and closed where possible. Doors and windows were not forced open.

### **External decorations**

External walls appear to have been painted.

The timber fascia boards are painted.

Visually inspected.

# Conservatories / porches

There are no conservatories or porches.

Visually inspected.

### **Communal areas**

The access track to the neighbouring property passes through land belonging to Glenerne. It is understood that there is a right of way in place for this.

Circulation areas visually inspected.



# Garages and permanent outbuildings

There is one outbuilding to the south of the house, consisting of a concrete floor, block walls and a pitched roof clad with fibre cement sheets.

Note: the fibre cement sheets may contain asbestos, depending on their age.

The doors and windows are missing. Internal dimensions 5.8m x 3.7m.

Visually inspected.

# Outside areas and boundaries

The property is surrounded by garden areas, which are mainly laid to grass, with stone walls to the boundaries. Flagstone and concrete paths around the house. Metal handrail fixed to the stone garden wall and house

Visually inspected.

# Ceilings

The ceilings are lined with plasterboard.
Sloping ceilings to the Sitting Room/Kitchen, with exposed ties

Visually inspected from floor level.

walls alongside the access path.

### **Internal** walls

Interior walls either consist of plaster on solid walls, or plasterboard/hardboard on timber framing.

Visually inspected from floor level. Using a moisture meter, walls were randomly tested for dampness, where considered appropriate.

# Floors including sub floors

Solid concrete ground floors throughout.

There is a ramped change of floor level between the Sitting Room/Kitchen and Bedrooms.

Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted.

No access to inspect the sub-floor areas.



# Internal joinery and kitchen fittings

Fitted floor and wall units to the Kitchen; stainless steel worktops and splashbacks.

4-panelled pine doors to the Bedrooms; half-glazed door to the Bathroom.

Softwood skirtings and facings.

Timber boarding to interior window cills.

Built-in cupboards were looked into but no stored items were moved.

Kitchen units were visually inspected excluding appliances.

# Chimney breasts and fireplaces

There is a fireplace recessed into the eastern gable, with a solid fuel stove.

Visually inspected. No testing of the flues or fittings was carried out.

### Internal decorations

Internal walls and ceilings are painted.

Interior woodwork is varnished or painted.

Stainless steel splashbacks to the Kitchen units; painted timber lining boards to the Bathroom.

Floor finishes include varnished flagstones and timber floorboards.

Visually inspected.

# **Cellars**

There are no cellars.

Visually inspected where there was safe and purpose-built access.

### Electricity

The property is served by a mains electricity supply to a distribution board and a single tariff meter.

Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.



Gas

There is no mains gas in Orkney.

There is a Calor Gas installation at the property, supplying the gas cooker; the gas bottles are located to the north elevation.

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

# Water, plumbing and bathroom fittings

There is a mains water supply to the property.

The pipework, where visible, is of copper and uPVC construction.

Sanitary ware includes:

Kitchen: stainless steel sink.

Bathroom: bath with mixer shower above and shower curtain on a rail, wash-hand basin, WC.

Visual inspection of the accessible pipework, water tanks, cylinders and fittings without removing any insulation.

No tests whatsoever were carried out to the system or appliances.

# Heating and hot water

The house is heated by a ground source heat pump, with underfloor heating.

The heating system is controlled by a programmer on the heat pump and an external weather sensor.

There is a hot water cylinder contained in the heat pump unit.

There is a solid fuel stove in the Sitting Room.

Accessible parts of the system were visually inspected apart from communal systems, which were not inspected.

No tests whatsoever were carried out to the system or appliances.

### Drainage

Drainage is understood to connect to a private septic tank on site.

External cast iron SVP outside the Bathroom.

Drainage covers etc were not lifted.

Neither drains nor drainage systems were tested.



# Fire, smoke and burglar alarms

Smoke detector fitted to the Hall ceiling.

Visually inspected.

No tests whatsoever were carried out to the system or appliances. NOTE: Fire Safety Legislation effective from February 2022 requires a smoke alarm to be installed in the room most frequently used for living purposes and in every circulation space on each floor. A heat detecting alarm must be installed in every kitchen area and all smoke and heat alarms must be ceiling mounted and interlinked. Where there is a carbon-fuelled appliance e.g. central heating boiler, open fire, wood burning stove etc, a carbon monoxide detector is also required. The purchaser(s) should appraise themselves of the requirements of this legislation and engage with appropriately accredited contractors to ensure compliance.

# Any additional limits to inspection:

At the time of our inspection the property was occupied and fully furnished with floors fully covered throughout.

Pitched roof coverings were inspected from ground level; a detailed inspection of condition was not undertaken.

An inspection for Japanese Knotweed or other invasive plant species was not carried out.


There was no access for inspection to the foundations or behind wall linings.

The drainage system was not open to inspection.

High levels of Radon gas have been recorded in areas of Orkney. No tests were carried out to detect the levels of gas in the property.





# The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. The rating is given on a scale of 1 to 100. Other than the cost of fuel for electrical appliances and for cooking, a building with a rating of 100 would cost almost nothing to run.

As we all use our homes in different ways, the energy rating is calculated using standard occupancy assumptions which may be different from the way you use it. The rating also uses national weather information to allow comparison between buildings in different parts of Scotland. However, to make information more relevant to your home, local weather data is used to calculate your energy use, CO<sub>2</sub> emissions, running costs and the savings possible from making improvements.

# The impact of your home on the environment

One of the biggest contributors to global warming is carbon dioxide. The energy we use for heating, lighting and power in our homes produces over a quarter of the UK's carbon dioxide emissions. Different fuels produce different amounts of carbon dioxide for every kilowatt hour (kWh) of energy used. The Environmental Impact Rating of your home is calculated by applying these 'carbon factors' for the fuels you use to your overall energy use.

The calculated emissions for your home are 32 kg CO<sub>2</sub>/m<sup>2</sup>/yr.

The average Scottish household produces about 6 tonnes of carbon dioxide every year. Based on this assessment, heating and lighting this home currently produces approximately 2.0 tonnes of carbon dioxide every year. Adopting recommendations in this report can reduce emissions and protect the environment. If you were to install all of these recommendations this could reduce emissions by 3.0 tonnes per year. 

# About the recommended measures to improve your home's performance rating

This section offers additional information and advice on the recommended improvement measures for your home

# 1 Heating controls (time and temperature zone control)

The heating system controls should be improved so that both the temperature and time of heating can be set differently in separate areas of your house; this will reduce the amount of energy used and lower fuel bills. For example, it is possible to have cooler temperatures in the bedrooms than in the living room provided internal doors are kept closed, and to have a longer heating period for the living room. Building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority building standards department and seek advice from a qualified heating engineer.

# 2 Solar water heating

A solar water heating panel, usually fixed to the roof, uses the sun to pre-heat the hot water supply. This can significantly reduce the demand on the heating system to provide hot water and hence save fuel and money. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check these with your local authority. You could be eligible for Renewable Heat Incentive payments which could appreciably increase the savings beyond those shown on your EPC, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). Details of local MCS installers are available at www.microgenerationcertification.org.

### 3 Solar photovoltaic (PV) panels

A solar PV system is one which converts light directly into electricity via panels placed on the roof with no waste and no emissions. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority. The assessment does not include the effect of any Feed-in Tariff which could appreciably increase the savings that are shown on this EPC for solar photovoltaic panels, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). Details of local MCS installers are available at www.microgenerationcertification.org.

### 4 Wind turbine

A wind turbine provides electricity from wind energy. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Wind turbines are not suitable for all properties. The system's effectiveness depends on local wind speeds and the presence of nearby obstructions, and a site survey should be undertaken by an accredited installer. Planning permission might be required and building regulations generally apply to this work and a building warrant may be required, so it is best to check these with your local authority. The assessment does not include the effect of any Feed-in Tariff which could appreciably increase the savings that are shown on this EPC for a wind turbine, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). ### PART 1 – GENERAL

#### 1.1 THE SURVEYORS

The Seller has engaged the Surveyors to provide the Single Survey Report. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited Energy Company.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Purchaser's lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors require to amend the valuation in consequence of such information, they will issue an amended Report to the Seller. #### PART 2 – DESCRIPTION OF THE REPORT

#### 2.1 THE SERVICE

The Single Survey is a Report by an independent Surveyor, prepared in an objective way regarding the condition and value of the Property on the day of the inspection, and who is a member of the Royal Institution of Chartered Surveyors. It includes an Energy Report as required by Statute and this is in the format of the accredited Energy Company.

### 2.2 THE INSPECTION

The Inspection is a general surface examination of those parts of the Property which are accessible: in other words, *visible and readily available for examination from ground and floor levels, without risk of causing damage to the Property or injury to the Surveyor.* 

All references to visual inspection refer to an inspection from within the property at floor level and from ground level within the site and adjoining public areas, without the need to move any obstructions. Any references to left or right are taken facing the front of the property.

The Inspection is carried out with the Seller's permission, without causing damage to the building or contents. Furniture, stored items and insulation are not moved.

Unless identified in the report the Surveyor will assume that no harmful or hazardous materials have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

The Surveyor will not carry out an asbestos inspection, and will not be acting as an asbestos inspector in completing a Single Survey of properties that may fall within the Control of Asbestos in the Workplace Regulations. In the case of flats it will be assumed that there is a duty holder, as defined in the Regulations and that a Register of Asbestos and effective Management Plan is in place, which does not require any expenditure, or pose a significant risk to health. No enquiry of the duty holder will be made.

#### 2.3 THE REPORT

The Report will be prepared by the Surveyor who carried out the property inspection and will describe various aspects of the property as defined by the headings of the Single Survey report with the comments being general and unbiased.
